TERMS AND CONDITIONS

NO.	SECTION	DESCRIPTION

3.	ELIGIBILITY	a. “Eligible Participant” means an individual customer who: i. Is a Malaysian citizen aged eighteen (18) years and above, who holds a valid and active ShopeePay wallet with active SPayLater services during the Contest Period; ii. makes an in-store purchase of a minimum of RM10 in a single receipt at any Participating Store; iii. completes payment using SPayLater as the payment method; and iv. complies with these Terms and Conditions, including ensuring that the transaction does not fall within any Excluded Transactions. 8.	PRIZE REDEMPTION & FORFEITURE	a. All winners must present a valid proof of identity and/or any other supporting documents requested by the Organiser for verification purposes. Failure to provide the required documents may result in disqualification and forfeiture of the prize. b. APPENDIX B
SUPERMARKET SWEEP RULES

- a. Each Grand Prize Winner is entitled to one (1) round of Supermarket Sweep (up to 5 minutes) at selected AEON Stores, as determined by the Organiser.
- b. Winners will be assigned a venue based on their location or availability at the Organiser's sole discretion.
- c. All transportation, travel, accommodation, meals, and any other expenses related to the winner's participation in the Sweep or the collection of the prize shall be fully borne by the winner. The Organiser shall not be held responsible for any such costs or arrangements.
- d. For safety reasons, winners who are pregnant, medically unfit, or otherwise physically unable to safely participate in the Sweep are advised not to do so, and may nominate a representative to participate on their behalf, subject to the Organiser's prior approval.
- e. If the Winner fails to attend or participate in the Sweep on the scheduled date, the prize shall be forfeited without compensation. The Organiser reserves the right to select an alternate winner.
- f. All retail items with a barcode or selling price displayed on the selling floor of the designated AEON Supermarket are eligible for the Sweep, EXCLUDING the following item categories:
 - i. Electrical items, Home Coordy products, or non-Supermarket items displayed in the Supermarket, including but not limited to televisions, coffee machines, cookware, etc.
 - ii. Perishable products, including but not limited to fresh vegetables, fruits, seafood, meat, eggs, and deli/dairy food, etc.
 - iii. Non-halal items, beer, wine, and liquor product categories.
- g. All items must be securely placed in the provided shopping trolley, and the total retail value must not exceed RM2,000. If the total value of the selected items exceeds RM2,000 ("**Prize Amount**"), the Winner may choose to either:
 - i. Pay the cash difference between the total bill amount and the Prize Amount, or
 - ii. Remove the excess item(s) from the shopping trolley prior to billing.
- h. Each Winner will be provided with a shopping trolley to participate in the Sweep at the designated AEON area. At any time, the Winner may exchange their full shopping trolley for an empty shopping trolley at the designated staging area.
